• There is a brief overview of relevant literature e.g. risk factors, geographic variation, trends over time, potential for prevention, treatment, quality assurance, emerging issues.

- Specific aspects of the topic are identified for more in-depth literature review.
- A good range of up to date, relevant literature is accessed from appropriate sources.
- There is a critical approach to appraising the literature.
- Findings of particular relevance to the topic of the PHR are identified.
